SUBJECT:- REVISED RATE/LIMIT FOR HEART/KIDNEY TREATMENT TO THE SINDH GOVT. EMPLOYEES.

I am directed to refer to the subject noted above and to state that in partial modification of this Department's circular of even number dated 4.1.2000, the Government of Sindh, with the approval of the competent authority, has been pleased to revise the rates for kidney/heart treatment to the Sindh Government employees, as follows subject to the condition that no arrears will be allowed for treatment taken prior to 9.10.2002:-


Open Heart Surgery:


II) Since the SIUT, Karachi, is providing treatment of Kidney diseases including transplantation free of cost, the old limit of Rs.125,000/- is enhanced and fixed at Rs.150,000/- to be paid to the patient who has carried out treatment in any hospital other than S.I.U.T.
