Sir,

I am directed to refer to this Department circular of even No. dated 22nd July, 1993 on the subject noted above and to state that the question of revision of the rates of contribution towards Provincial Benevolent Fund was under consideration of the Government for quite some time due to growing liability and revision of rate of grants/stipends long ago.

2. It has now been decided by the Government with the approval of competent authority to revise the rates of deduction towards Benevolent Fund as under :-

| c) Government Servants in BPS-20 to BPS-22. | 2% of pay without ceiling restriction.  |

2. These orders shall take effect from 1.1.2000.
