SUBJECT: - INCREASE OF MINIMUM PENSION FROM RS.300/- PER MONTH TO RS.1500/- PER MONTH FOR PENSIONERS / FAMILY PENSIONERS OF GOVERNMENT OF SINDH

I am directed to refer to this Department's circular letter No. FD(SR-III)3 / 42 – 88©, dated 21st July, 1988, on the subject noted above and to state that the Government of Sindh has been pleased to sanction with effect from 1st July, 2009, the increase in minimum pension from Rs.300/- p.m. to Rs.2000/- per month to civil pensioners of the Sindh Government.

2. Similarly, family pension allowed to the families of retired government employees under the Pension-cum-Gratuity Scheme 1954, and Liberalized Pension Rules, 1977 has also been increased with effect from 1st July, 2009 from Rs.150/- per month to Rs.1000/- per month.

3. Commutation of any part of the increase allowed vide this circular will not be admissible.




