**OFFICE MEMORANDUM**

**SUBJECT: - MINIMUM PENSION.**

In continuation of this Department's Circular No. FD(SR-III)3/42 - 88 dated 3<sup>rd</sup> November 2009 and Corrigendum of even number dated 10<sup>th</sup> November 2009, on the subject cited above, the Government of Sindh is pleased to sanction with effect from 1<sup>st</sup> July, 2010 the increase in minimum pension from Rs.2,000/- per month to Rs.3,000/- per month to civil pensioners of the Provincial Government.

2. Similarly family pension allowed to the family of a retired government employee under the Pension-cum-Gratuity Scheme 1954 and Liberalized Pension Rules 1977 has also been increased from current rate of 50% to 75% i.e.. Rs.1, 000/- per month to Rs.2, 250/- per month.

3. Commutation of any part of the increase allowed vide this O.M. will not be admissible.


