## ORDER.

No. FD (SR-III)-10(06)/2011: In supersession of this office order No. FD (SR-III)-10(06)/2011 dated 12<sup>th</sup> September, 2011, sanction of Government of Sindh is hereby accorded for grant of Fixed Daily Allowance at the following rates to 82,769 personnel of police force performing field duties, with effect from 01.09.2011:-

2. Further, sanction of Government of Sindh is hereby accorded for grant of Risk Allowance @ 50% of the running basic pay of Basic Scale 2008, which shall stand frozen to that level, to 82,769 personnel of police force performing field duties, with effect from 01.09.2011.

3. In addition to above, sanction of Government of Sindh is also accorded for increase in Ration Allowance and Constabulary Allowance at following rates:-

4. On admissibility of Fixed Daily Allowance, Risk Allowance and increase in Ration Allowance and Constabulary Allowance as above, Adhoc Allowance-2010 @50%, Special Additional Allowances (Special Allowance), TA (Fixed), Hardship Allowance and un-attractive area allowance admissible/not admissible (as the case may be) to above field officers and officials, are hereby abolished.

5. All those entitled to Fixed Daily Allowance under this order shall not be entitled to Daily Allowance in their TA Claims within their respective jurisdictions.

6. This order will not be applicable to non-field officers and officials drawing non-field duty allowance and also personnel of CID, Bomb Disposable Squad, Rapid Response Force and VVIP Security who are allowed Risk Allowance, Special Allowances and special packages, which shall remain intact.


7. Administrative Department is advised to provide audit copy along with schedule of posts of field officers and officials, total 82,769 in number, for authentication.
